



## Limited Warranty for SuprFlex Impact Panel General Information

Amarr SuperFlex panels are manufactured with the highest quality material and standards of workmanship in the industry. This Amarr Limited Warranty applies ONLY TO THE SUPERFLEX PANELS installed and maintained under normal and intended usage at the commercial/industrial location of the original installation in accordance with manufacturer's instructions.

Amarr warrants SuperFlex panels to be free from flaws in material and workmanship under normal use for applicable warranty period provided below. All door material that is not SuperFlex panels is not covered under this limited warranty. Material not covered includes but is not limited to door sections, track, springs and hardware.

The applicable Warranty periods from the date of purchase are as follows:

\*Warranty applies to the SuperFlex impact panel(s) only. Warranty does not apply to other door material, sections, track, springs or hardware that the SuperFlex may be installed in.

Claims under this warranty must be made in writing promptly after discovery of the defect. Amarr Company warrants that upon inspection, Amarr Company will, at Amarr Company's option, repair, replace, or refund at original purchase price items of Amarr SuperFlex panel(s) that are defective in material or workmanship. Any charges for freight, removal, installation or labor shall be the responsibility of the original purchaser.

**This Limited Warranty does not apply to any damage or deterioration caused by:** improper installation, abuse, improper operation, negligence, or failure to maintain and adjust the SuperFlex™ Panel properly. Parts requiring replacement due to damage resulting from vehicle impact, abuse, or improper operation are not covered by this warranty. Amarr DISCLAIMS ANY RESPONSIBILITY OR LIABILITY FOR ANY LOSS OR DAMAGE OF ANY KIND (INCLUDING WITHOUT LIMITATION, DIRECT, INDIRECT, CONSEQUENTIAL OR PUNITIVE DAMAGES, OR LOST PROFITS OR LOST PRODUCTION) arising out of or related to the use, installation or maintenance of the SuperFlex Panel (including premature product wear, product failure, property damage or bodily injury resulting from use of unauthorized replacement parts or modification of the SuperFlex Panel). Amarr's sole obligation with regard to a SuperFlex Panel that is claimed to be deficient in material or workmanship shall be as set forth in this Limited Warranty. This Limited Warranty will be null and void if the original purchaser does not notify Amarr's warranty department within ninety (90) days after the product deficiency is discovered. This warranty does not cover any materials or workmanship provided by anyone other than Amarr Company.

THE LIMITED WARRANTIES AND REMEDIES SET FORTH ABOVE ARE EXCLUSIVE AND IN LIEU OF ALL OTHERS, ORAL OR WRITTEN, EXPRESSED OR IMPLIED. THIS LIMITED WARRANTY EXCLUDES ANY LOSS OR DAMAGE NOT SPECIFICALLY UNDERTAKEN HEREIN, INCLUDING WITHOUT LIMITATION, ANY CONSEQUENTIAL OR INCIDENTAL DAMAGES, SUCH AS DEATH, INJURY, DAMAGES TO PROPERTY OR DAMAGES ARISING FROM LOSS OF USE OF ANY PRODUCT OR FACILITY. ANY AND ALL IMPLIED WARRANTIES, INCLUDING ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, ARE HEREBY EXPRESSLY EXCLUDED AND DISCLAIMED. TO THE EXTENT THAT ANY IMPLIED WARRANTIES ARE NOT DISCLAIMED, THE DURATION OF ANY IMPLIED WARRANTY IS LIMITED TO THE DURATION OF THE EXPRESS LIMITED WARRANTIES HEREIN.
